## StoryMaps Terms of Use ("Terms")

IMPORTANT—READ CAREFULLY

These Terms comprise a legal agreement between you and Environmental Systems Research Institute, Inc. ("Esri"), a California corporation located at 380 New York Street, Redlands, California 92373-8100 USA. These Terms govern your use of StoryMaps.

Use of other Esri products or services is subject to the appropriate written agreement or click-through license provided, and are separate from these Terms.

#### **Your Acceptance of the Terms**

YOU UNDERSTAND THAT BY CLICKING THE "I ACCEPT" BUTTON, BY USING THE STORYMAPS WEBSITE ("THE SITE") AND/OR YOUR PERSONAL ACCOUNT, YOU ARE AGREEING TO BE BOUND BY THESE TERMS. IF YOU DO NOT ACCEPT THESE TERMS IN THEIR ENTIRETY, YOU MAY NOT ACCESS OR USE THE SITE.

YOU MUST BE AT LEAST EIGHTEEN (18) YEARS OLD TO USE THE SITE. If you are not yet 18 years old, your parent or guardian may create a personal account for you on your behalf. Esri may take steps to verify the accuracy of any information you provide, including contact information for a parent or guardian.

#### **Modifications to the Terms**

Esri may, from time to time, modify or replace these Terms or the Esri Privacy Policy, which may affect your rights to use StoryMaps. Modified or replaced Terms or the Esri Privacy Policy will be made available to you on the Site. You understand and agree that your access or use of StoryMaps after the modified or replaced Terms or Esri Privacy Policy is posted will signify your acceptance to those Terms or the Esri Privacy Policy. You further understand that it is your responsibility to read the current Terms or the Esri Privacy Policy - Esri will not contact you letting you know they have been modified or replaced.

#### Your Use of StoryMaps

Esri grants to you a personal, revocable, nonexclusive, nontransferable right to use StoryMaps solely in conjunction with your authorized use of the StoryMaps Site in accordance with these Terms.

## **Limitations on Your Use of StoryMaps**

Any use rights not granted herein or otherwise agreed to in writing between you and Esri are prohibited. In particular, you may not (i) use StoryMaps in such a manner as to adversely affect Esri's commercial interests; (ii) reverse engineer, decompile or disassemble StoryMaps; (iii) manually or systematically collect or scrape data from StoryMaps; (iv) post any data that Esri, in its sole discretion, advises to be false, inaccurate, misleading, disruptive, unlawful, harmful, threatening, abusive, harassing, defamatory, pornographic, vulgar, obscene, hateful, or racially or ethnically-motivated, or otherwise objectionable; (v) use StoryMaps for illegal, improper, or inappropriate purposes (including but not limited to distribution of content or information in violation of the proprietary or privacy rights of others); (vi) probe, scan, or test the vulnerability of StoryMaps or breach any security or authentication measures used by StoryMaps, or (vii) access or use StoryMaps in violation of any applicable local, state, national or foreign laws, rules, regulations, guidelines, directives, treaties or regulations of all government authorities. You will not remove, obscure, or alter copyright, patent, trademark, or other proprietary rights notices affixed to the StoryMaps Site. Your rights are subject to your compliance with these Terms. Making unauthorized copies or distribution of Site content or otherwise violating these Terms may result in the prohibition on your use of StoryMaps through termination of your personal account, and further legal action.

#### **Esri's Proprietary Rights to StoryMaps**

StoryMaps, StoryMaps user documentation and Esri's trademarks are protected by United States laws and applicable international laws, treaties, and conventions regarding intellectual property or proprietary rights. You do not receive title to or ownership of StoryMaps, StoryMaps user documentation, Esri's and its licensors' data, or Esri trademarks hereunder.

#### **Esri Data Licensing Terms and Use Restrictions**

When using StoryMaps, you may access and use data provided on the StoryMaps Site ("Esri Data") in accordance with these Terms. As used in these Terms, "Esri Data" includes but is not limited to software, data, images, photographs, animations, video, audio, or music; text, scripts, or markup code; service packs, patches, web services, publicly available APIs or JavaScript libraries, documentation, or other information, electronic resource, or service provided on the StoryMaps Site. You may only use Esri Data with your authorized use of StoryMaps in accordance with these Terms. You may create representations of Esri Data in hard-copy or static, electronic format (e.g., PDF, GIF, JPEG, HTML) in Story Maps for the purposes of visualizing Esri Data (including basic interactions such as panning, zooming, and identifying map features with simple pop-ups) subject to the restrictions set forth in these Terms and provided you affix an attribution statement to the Esri Data representations acknowledging Esri or its applicable licensor(s) as the source of the portion(s) of the Esri Data used for the Esri Data representation.

## Third Party Data and/or Imagery Licensing Terms and Use Restrictions

The StoryMaps Site may contain third-party data and/or imagery. Use of third-party data and/or imagery may be subject to such third party's License Agreement or additional use restrictions. You are responsible for compliance with all applicable third-party license agreement(s). Third-party Use Restrictions may be provided with the data (such as with metadata) or under Esri's <u>Use of Data Restrictions</u>. The third-party license agreement(s) and any applicable use restrictions may be modified by Esri from time to time and it is your responsibility to check for updates to these license agreements or use restrictions. If a modification of any third-party license agreement, or use restrictions is unacceptable, you may cancel your access upon written notice to Esri or discontinue use of the StoryMaps, as applicable. Continued use of StoryMaps will be deemed acceptance of any modifications.

Alternatively, when using StoryMaps, you may have the opportunity to leave the StoryMaps Site in order to access and download additional content provided by third-parties, including software, services, data, imagery, and fonts. You acknowledge that third-party content is solely the responsibility of the third-party content provider. These Terms do not convey to you any rights to access or use third-party content (including copying, distributing, creating derivative works from, or publicly displaying). Access and use of third-party content may require that you agree to different or separate terms, conditions, and restrictions. Agreeing to any such terms and conditions will be between you and the third-party content provider, and will not affect these Terms or any separate agreements you may have with Esri.

#### **Your Proprietary Rights to Your Data**

You retain all right, title, and interest in your stories created with StoryMaps and in your data, including, but not limited to your files, designs, data sets, images, documents or similar material created by you and submitted or uploaded by you to StoryMaps ("your data"). You represent and warrant that your data is and will remain within your right to use, your use of StoryMaps will comply with all applicable laws and regulations and you will not infringe the rights of any third party (including without limitation any intellectual property rights or privacy rights) in using StoryMaps. You hereby grant Esri (and its service providers) a nonexclusive, nontransferable, worldwide right to host, run, and reproduce your data for the purpose of enabling your use of StoryMaps. Esri (and its service providers) may also share your publicly-shared stories to, including, but not limited to, the StoryMaps gallery, the StoryMaps feed, and/or StoryMaps social media and newsletter (shared as a link to your story and/or media from your story). Except as otherwise provided herein, Esri will not access, use, or disclose your data without your permission, except to comply with the law or any court or government order.

#### **Privacy**

In the course of using StoryMaps, you may submit your personal data to Esri. Personal data is anything that can potentially identify you or any other person. Esri's Privacy

<u>Statement</u>, together with any related privacy notices or statements (collectively, "Esri privacy statements"), detail how we treat your personal data. You agree that Esri may use and share your personal data in accordance with the Esri privacy statements and applicable data protection laws.

Do not submit others' personal data to Esri in the course of using StoryMaps.

## **Security of Your Account**

**Passwords and Account Information.** The StoryMaps Site requires you to create and use a personal account. Esri publishes its security capabilities at <a href="https://trust.arcqis.com/en/">https://trust.arcqis.com/en/</a>.

By creating a personal account, you:

- (a) are responsible for maintaining the confidentiality of the password for your personal account;
- (b) are fully responsible for all activities that occur under your personal account unless access to your account number, account name, or password was obtained through no fault or negligence of your own;
- (c) agree to provide truthful and accurate information at all times when using StoryMaps;
- (d) understand that using a false or incomplete name or e-mail address, impersonating any person or entity, or falsely stating or otherwise misrepresenting your affiliation with a person or entity will result in immediate removal of your personal account and termination of any rights provided herein;
- (e) will create an account name and use an e-mail address specific to you;
- (f) agree not to share personal accounts with other users;
- (g) understand that sharing account information or allowing others to access your account will result in the removal of your personal account;
- (h) understand that user usernames are provided on a first-come, first-served basis;
- (i) agree not to sell, solicit, or inactively hold usernames for future use (Inactive accounts may be renamed at any time without notification);.
- (j) agree to notify Esri of any unauthorized use of your password or account or any other breach of security as soon as you become aware of such use or breach, by completing the information requested at <a href="https://trust.arcgis.com/en/security-concern/">https://trust.arcgis.com/en/security-concern/</a> to Report a Security of Privacy Concern; and
- (k) understand that logging off from your account at the end of each session is recommended.

Esri shall not be liable for any loss or damage arising from your failure to comply with this section

#### **Termination of Your Personal Account**

Esri reserves the right to monitor your use of Esri websites. Esri reserves the right to suspend or cancel your account or access to the StoryMaps Site or other Esri websites

at any time, or take any other appropriate measures in its legal capacity to enforce these Terms. If you have your personal account removed for not following these Terms, you understand and agree that you shall not receive a refund or exchange for any credits, unused time on a subscription, any subscription fees for any portion of your use of StoryMaps and you may not be allowed to return or create a personal account in the future. Upon termination of these Terms, all rights and obligations owed by the parties shall cease except for those concerning either party's proprietary rights and the rights and obligations concerning your passwords and personal account information, which shall continue indefinitely.

Neither these Terms nor the Esri Privacy Policy governs or protects any information that you have publicly disclosed on the Site. It is your responsibility to review what information you wish to share on the Site. In the event that you choose to publicly share contact information, you do so at your own risk. Further, as indicated on the Site in the space provided to you, you are encouraged to notify visitors to any StoryMaps page(s) you create how to contact you in the event the visitor believes you have used their content or data without their authorization.

#### **Electronic Notice**

You consent to receive notices electronically from Esri at the email address you have provided and acknowledge that these electronic notices satisfy any legal requirements that such communications be in writing.

#### **Esri's Copyright Policy and Right to Remove Your Data**

Esri's copyright policy is to respond to notices by third parties of alleged copyright infringement under the U.S.'s Digital Millennium Copyright Act ("DMCA") or similar statutes from other jurisdictions, so long as the notice is clear, complies with the statutory requirements, and is consistent in form with the DMCA's Infringement Notification. Upon receipt and review of an Infringement Notification by a third-party, Esri may disable or remove access to, or delete your StoryMaps story if there is reason to believe that uploading your data or third-party data to the Site for use with StoryMaps materially violates these Terms or the DMCA. If Esri disables or removes access to your StoryMaps story in response to such an Infringement Notification, Esri will make a good faith attempt to contact you regarding the affected StoryMaps story and the allegedly infringing third-party data so that you may have an opportunity to file a Counter Notification. Esri reserves the right to terminate the account(s) of repeat infringers or offenders, as applicable.

## **StoryMaps Subscription Plans**

StoryMaps subscription plans are Basic and Premium. The Basic plan is free and includes basic product features with limits on the number of items that can be created.

The Premium plan is a paid monthly or annual subscription with no limit on the number of items that can be created. Monthly subscription plans will be set to auto-renew by default under the Esri Auto-Renewal Terms.

Customers can cancel their subscription at any time. When the canceled Premium subscription term expires, the Premium subscription automatically reverts to a Basic account. For annual Premium subscriptions, Esri will provide a full refund if canceled within the first 30 days. Esri will not provide a refund if canceled after 30 days, except where required by law. Customers can continue to use their Premium subscription until the term expires. Esri will provide no refund for canceled monthly Premium subscriptions. To request a refund, contact <a href="mailto:services@esri.com">services@esri.com</a> and include your username, order date, and contact information.

Basic accounts will be deactivated after 1 year of inactivity. Users have 30 days to reactivate before account, subscription and related data are canceled/deleted.

Subscription fees are subject to change without prior notice. Unless stated otherwise, the fees include all applicable taxes, levies, or duties imposed by taxing authorities. Esri uses third parties such as a credit card processing company to bill customers for subscription fees. When you sign up for StoryMaps, Esri will share your personal information only as necessary for the third party to provide that service, subject to the Esri Privacy Policy.

#### **No Warranty**

STORYMAPS IS PROVIDED "AS IS" WITHOUT ANY WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT.
